<p>Financial Aid for summer is limited. Students receiving the Pell Grant may have remaining funds to use during summer terms if they were not full time (12 or more credit hours) during fall and spring terms. In order to receive Pell in the summer, Pell recipients must bring a copy of their summer schedule to the financial aid office for determination of eligibility; aid is not automatically awarded for summer. NC grants are not funded and are unavailable in the summer. Limited institutional funds are awarded on a first-come, first-served basis until funding is depleted. To request institutional funds, students must bring a copy of their schedule to the Financial Aid Office for review.</p>	<p>Refunds are processed only for classes officially dropped using the SCC Course Change form.</p> <p>100% Refund: Session "A" & "B" classes must be dropped by May 22.</p> <p>Session "C" classes must be dropped by June 26.</p> <p>75% Refund: Session "A" classes dropped May 23-May 30; Session "B" classes dropped May 23-24; Session "C" classes dropped June 27-June 28</p> <p>No Refund: Classes dropped after May 30 for Session "A" classes. Classes dropped after May 24 for Session "B" classes. Classes dropped after June 28 for Session "C" classes.</p>	<p>Required for all SCC students. Issued at the Dempsey Student Center.</p> <p>Student ID: You must show a government issued ID (i.e. driver's license), and a receipt of tuition paid in full.</p> <p>Parking Permit: Register your vehicle online before picking up your sticker. Go to the SCC homepage, click on the MySCC link, then the Parking Sticker link. HYBRID or INTERNET COURSES: For HYBRID courses, instructors will provide direction for the online component in the first class meeting. If you do not complete the activity, you will be dropped from the course.
